- 1. The administrative and accounting reports for 2013 are discussed and approved.
- 2. Prof. Dr. J. Van de Voorde attended the IUPS Council Meeting during the IUPS World Congress in Birmingham (UK). He commented the efforts of this Society to include Societies of developing countries. Candidatures of Bangladesh, Malta and Nepal for IUPS membership were approved. IUPS World Congress 2017 will take place in Brazil and in 2021 in China.
