Minutes of the General Assembly of the Belgian Society of Fundamental and Clinical Physiology and Pharmacology and of the National Comittee of Physiology and Pharmacology

Louvain-en-Woluwé (Université Catholique de Louvain), November 8th, 2008

The General Assembly started at 13.30h and was chaired by Prof. Dr. E. Hermans

- 1. The administrative and accounting reports for 2008 were approved.
- No international congresses were organized by IUPS and IUPHAR in 2008. Congresses of EPHAR and EACPT were respectively organized in Manchester (United Kingdom) and Québec (Canada). Prof. V. Seutin, who represented our Society at EPHAR in Manchester, reported that the Federation of European Pharmacological Societies feels that it has a too low profile. There is little interest in the activities of the European Society, which has very limited resources. EPHAR will try to improve the situation by being more visible at world congresses. The first purpose is to be actively present in the "Worldpharma"

2010" congress in Copenhagen (Denmark). The idea of EPHAR is to propose general lectures in pharmacology for this meeting. If our members can propose speakers from

- Belgium or abroad, they can contact our secretary general.
- 3. EPHAR asks to increase the membership fee of the European societies from 1 to 2 euro per member. The Assembly agreed. As usual, the membership dues to the other European Societies FEPS and EACPT will be paid. The Belgian Academy of Sciences will be asked to pay the membership dues to IUPS and IUPHAR.
- 4. The annual membership fee for our Society remains 30 €. The Assembly urges the members to pay their dues. At present only 40% do so. Members who fail to pay their dues for two successive years will be removed from the list of members.
- 5. Prof. Dr. Renaud Beauwens (Université Libre de Bruxelles) was elected as Second Vice-Chairman.
